ORDER

An application for affiliation of an unaided self financing B.Ed. Training College was received from the Chairperson, Valiyam Memorial Educational and Charitable Society, Edapallykotta, Chavara, Kollam for the academic year 2007-08, vide paper read as (1) above.

Vide paper read as (2), the Government of Kerala had issued NOC for starting the Training College during 2003-04 subject to affiliation of the University and approval of NCTE.

Vide paper read as (3), the NCTE granted recognition to the Valiyam Memorial College for Teacher Education, Edapallykotta, Chavara, Kollam, for starting the B.Ed. Degree Course of one year duration from the academic session 2006-07, with an annual intake of 100 students.

Vide paper read as (4), the Hon'ble High court of Kerala disposed of the writ appeal on the basis of the statement of the Standing Counsel for Kerala University that University would pass orders on the application for affiliation made by the petitioner, the Chairperson, Valiyam Memorial Educational and Charitable Society, Chavara, Kollam, for the academic year 2007-08.

The Vice-Chancellor, on the basis of the judgement of the Hon'ble High Court of Kerala, and in the light of the reports of the Inspection Commission considered the question of grant of provisional affiliation to the proposed Training College by the Valiyam Memorial Educational and Charitable Society, Chavara, Kollam, ordered to grant provisional affiliation to the Valiyam Memorial College of Teacher Education, Edapallykotta, Chavara, Kollam for the conduct of the B.Ed. Degree Course with the Optional Subjects :

1) English 2) Physical Science 3) Social Science and 4) Commerce with an annual intake of 25 students each, for the academic year 2007-08, subject to the rectification of deficiencies pointed out by the Inspection Commission and ratification by the Syndicate of the action taken and subject to final orders of the Hon'ble High Court in cases pending before it.

Vide paper read as (5), the Chairperson, Valiyam Memorial Educational and Charitable Society, Chavara, Kollam, had furnished the compliance report on the rectification of the deficiencies pointed out by the Inspection Commission.

Vide paper read as (6), the Syndicate at its meeting held on 28.6.2007 considered and ratified the action taken by the Vice-Chancellor in having granted provisional Affiliation to the Valiyam Memorial College of Teacher Education, Edapallykotta, Chavara, Kollam for the academic year 2007-08.

Vide paper read as (7), the Chairperson, Valiyam Memorial Educational and Charitable Society had executed a letter of undertaking dated 13.6.2007 agreeing that the Educational Agency shall grant admission and levy fees from the students as per the provisions contained in the Kerala Professional Colleges or Institutions Act 2006 subject to such modifications as may be prescribed by the Government from time to time and as per the Agreement executed on 13.6.2007, the Educational Agency agreed to abide by the conditions regarding extent of land, Building, laboratory, library, playground etc. Service conditions of teaching/non-teaching staff fee levied from the student, fee and other charges levied from the Educational Agency etc. as prescribed by the University and Government from time to time.

Vide paper read as (8) the Educational Agency has furnished a fixed deposit Receipt of Rs.5 Lakhs towards financial Guarantee for the Valiyam Memorial College of Teacher Education, Edapallykotta, Chavara, Kollam.

Vide paper read as (9) the Chairperson Valiyam Memorial Educational & Charitable Trust has submitted an agreement, agreeing to keep intact such area of land as required for the purpose of complying with the statutory requirements for affiliation of Colleges and Courses of Studies.

Sanction has therefore, been accorded by the University of Kerala to the Valiyam Memorial College of Teacher Education, Edapallykotta, Chavara, Kollam being granted provisional affiliation for the academic year 2007-08 with an annual intake of 100 students with 25 seats in each of the following subjects.

- 1) English
- 2) Physical Science
- 3) Social Science and
- 4) Commerce

The provisional affiliation granted is subject to the condition that there will not be any financial commitment on the part of the Government and the University and subject to the provisions in the Kerala University Act, 1974, and the Statutes thereunder and subject to the final orders of the Hon'ble High Court in cases pending before it.

### ORDER

Provisional affiliation was granted vide paper read as (1) to the Valiyam Memorial College of Teacher Education, Chavara for the academic year 2007-08, with the following optional subjects with annual intake of 100 students.

- English
- Physical Science
- Social Science
- Commerce

The Chairperson, Valiyam Memorial College of Teacher Education, Chavara, vide paper read as (2) above,

requested to change the Commerce optional subject offered in the College to Natural Science optional subject for want of sufficient number of students for Commerce optional.

As per the revised norms and regulations of NCTE 2014, it was decided to limit the intake of B.Ed courses in the Government /aided as well as Self Financing B.Ed college to one unit (50 seats) vide paper read as (3) above.

The Syndicate vide paper read as (4) above, considered the above request and resolved to conduct inspection in the college.

The Syndicate vide paper read as (5) above, considered the reports of inspection in respect of the change of optional subject and resolved to grant permission for changing the optional subject for B.Ed degree course from 'Commerce' to 'Natural Science', within the sanctioned strength of 50 students, in the Valiyam Memorial College of Teacher Education, Chavara, Kollam, from 2017-18 admission onwards.

Sanction has therefore been accorded by the Vice-Chancellor for permission to **change the Commerce optional subject offered in the Valiyam Memorial College of Teacher Education, Chavara, Kollam to 'Natural Science'** for B.Ed degree course within the present sanctioned strength of 50 students, [as per the revised norms and regulations of NCTE 2014], from **2017-18 admission onwards.**


